Online filled in applications received by Speed Post/Courier or any other means after the last date & time will not be accepted irrespective of the date of booking. The Candidates have to submit the copy (photocopy) of the online downloaded application Form form along with necessary enclosures should reach the Office of the Hon'ble Committee within the date and time specified.

- ii. The Candidates shall ensure that they should upload the required documents in the online application form in our website only.
- iii. This Consortium shall not be responsible for any error in your uploaded online data
- iv. No oral enquiry would be entertained.
2. The Government orders issued and to be issued from time to time pertaining to any of the matters contained in the prospectus should be read as part and parcel of this prospectus and such terms and conditions in the Government order are deemed to have been incorporated in this prospectus.
3. **Admission to the Entrance Examination does not confer on the candidate the right of admission if found to be ineligible later.**
4. The Application Register Number (AR No.) and Application Number (Appln No.) will be assigned by this Consortium.
5. It shall be the responsibility of the candidate to give the correct mailing address in the online application, Hall Ticket and Acknowledgement Card. If there is any change of address, it should be intimated immediately to the Consortium in writing.

ELIGIBILITY CRITERIA:-

6. Candidates should possess a B.Pharm.Degree awarded by the Tamilnadu Dr.MGR Medical University or any other University recognized as Equivalent thereto by the Tamilnadu Dr.MGR Medical University / Pharmacy Council. Candidates who have qualified from other Universities should obtain and produce an Eligibility Certificate from the Tamilnadu Dr.MGR Medical University at the time of admission.
7. Candidates seeking admission to the Postgraduate M.Pharm.Degree course should have obtained not less than 55% for OC, BC, BCM, MBC and 50% for SC, SCA and ST of the total marks obtained in all semester subject marks taken together in the B.Pharm.Degree course. In case of failure(s) the pass marks in the subsequent attempts shall be taken for calculation purpose. Number of attempts are not considered for calculation of marks.

PROCEDURE FOR FILLING AND SUBMISSION OF THE APPLICATION:-

8. The candidates should send the Application (Online) in the prescribed form only.
9. The Candidates shall fill the online application carefully and legibly.
10. Application with incomplete or insufficient particulars or without enclosures or those received after the last date mentioned will be summarily rejected (without any intimation to the candidate).
11. Candidates should write his / her Name & Address in the Hall Ticket.
12. The candidates should put their signature in the appropriate column without fail. Filled up applications without the signature of the candidates will be rejected.
13. The Candidate shall submit only ONE application form (online) for admission to the Entrance Examination.
14. Candidates must enclose only self **attested Xerox copies** (not originals) of the following documents in the order indicated below along with the application, failing which the application is liable for rejection.
 - a. B.Pharm.Degree Certificate or provisional pass certificate from the University concerned to which the college is affiliated.
 - b. First year/ first Semester to final year/ final Semester B.Pharm.Mark sheets issued by the University concerned.
 - c. Permanent Registration Certificate of the State Pharmacy Council of the B.Pharm.Degree.
 - d. Birth Certificate or copy of H.Sc.Certificate / School Leaving Certificate / College Leaving Certificate as evidence for Date of Birth.
 - e. Attempt Certificate in Final Year B.Pharm.course from the Head of the Institution studied in.
 - f. Eligibility Certificate from the TamilNadu Dr.M.G.R Medical University for candidates who have qualified for the under graduate course from Universities other than the TamilNadu Dr.MGR Medical University.(This certificate shall be produced at the time of admission).

CONDUCT OF EXAMINATION:-

15. (a) The Entrance Examination will be conducted only at **Chennai** as scheduled below:

- (b) The Results will be published within three days after the commencement of Entrance Examination.
- (c) Fees : Rs.70,000/- fixed by the Fee Fixation Committee, Gandhi Mandapam Road, Guindy, Chennai – 600 025.

HALL TICKET:-

16. Only candidates with valid Hall Tickets will be allowed to enter the Examination Hall.
17. The Hall Tickets will not be sent by post need to be downloaded from the portal were the application submitted, using individual login credential

ENTRANCE EXAMINATION – GUIDELINES:-

18. Candidates admitted for the Entrance Examination will have to come to the Examination Centre at their own expense and make their own arrangements for stay if necessary.
19. (a) **Candidates are advised to be present at 01.00 p.m in the Examination Centre.**
- (b) **They are required to be seated on their respective seats 15 minutes before the commencement of examination and to fill up the 1st page of question booklet.**
- (c) **Question Booklets should not be opened by the Candidates before 02.00 p.m**
- (d) **Candidates coming 30 minutes after the commencement of the Examination will not be permitted to appear for the Examination.**
20. No candidate will be allowed to carry any text material printed or written, bits of paper, electronic and telecommunication devices like pagers, cellular phones, or electronic diary etc., inside the Hall.
21. **No candidate shall be allowed to leave the hall before the end of the examination.**
22. **Candidates shall maintain strict silence. Any misconduct will entail forfeiture of the right to continue the Examination. His / Her Answer Sheet will not be considered for valuation.**
23. Answers should be shaded with a **Ball Point Pen** in the OMR answer sheet as per the instructions given and if it is shaded with any other item the answer sheets will not be considered for valuation without any intimation to the candidate.

SCHEME OF ENTRANCE EXAMINATION:-

24. Candidates seeking admission for management quota should write the Post Graduate M.Pharm.Degree Course Entrance Examination conducted by this Consortium.
25. The Entrance Examination will be of the undergraduate level covering all subjects and will contain 125 objective type questions each with four responses (A B C D) in English. Number of questions in each subject is as shown in the **Annexure – I**.
26. Each question will carry 1 (one) Mark. There will be **NO NEGATIVE MARKS** for incorrect responses. Zero marks will be given for questions not answered. When more than one answer is indicated or when it is illegible, no mark will be awarded for that question. The Maximum marks will be computed to 90.
27. No candidates will be allowed to take back the Question Booklets and a request for provision of Xerox copies of the Question Booklet, Answer Sheet or Answer Key will not be entertained.

EXPERIENCE MARK:-

28. One mark for each completed year of experience as on 30.04.24 which is calculated from the last date of the month of passing B.Pharm.Degree Examination, subject to a maximum of 10 marks shall be awarded as experience mark.

DETERMINATION OF INTER-SE MERIT:-

29. In case of two or more candidates obtaining equal marks out of total of 100 marks, the inter-se-merit of such candidates shall be determined on the basis of the following order of preference.
 - a. Marks obtained in the Entrance Examination.
 - b. Least number of appearance in the final Semester of B.Pharm.,examination.
 - c. Total marks obtained in the final Semester / final year examination of B.Pharm course.
 - d. Seniority in age will be given preference.

MERIT LIST:-

30. The Merit list will be drawn for a Total mark of 100 by computing the Entrance Examination Marks and the Marks for experience. (90 marks for entrance examination +10 marks for experience).
 - a. Marks awarded for Entrance Examination: Maximum 90 marks.
 - b. Experience marks for all candidates to a maximum of 10 marks. Fractional values of a year will not be counted for awarding marks for experience.
 - c. In the case of candidates who have furnished the mark sheets only in grades, the should furnish the actual marks obtained from the University. If not, only the minimum marks of the grade will be considered.
 - d. The marks obtained by the candidates in the Entrance Examination shall be considered for the purpose of preparing the merit list.

DECLARATION OF RESULTS:-

31. The Merit List will be displayed on the website www.tnppcahs.org
32. After the publication of Merit List, the candidates should contact the respective colleges. The list of affiliated colleges are in **Annexure II**. The Candidates shall also visit the Tamilnadu Dr.MGR Medical University website www.tnmgrmu.ac.in
33. There will be NO Rechecking / Revaluation / Retotalling of answer sheets.

ADMISSION PROCEDURE:-

34. Candidates selected for admission should give a declaration that he / she is liable for forfeiture of admission if suppression of facts are found at any time during or after admission to the course. The admission shall be liable for cancellation based on declaration at any time during or after the admission to the course.

DURATION OF COURSE:-

17. The duration of the Post Graduate M.Pharm.Degree course shall be 2 years.

EXAMINATION FEES:-

35. The Candidate should pay only **Rs.1,500/-** in our M.Pharmacy online application form before downloading the application from our website. Payment mode is only via online from our payment gate way.
36. Special fees and other fees are to be paid at the time of admission in the respective colleges.

STRICT INSTRUCTION:-

37. The candidates who join M.Pharm. Degree course should not indulge in any kind of agitation / strike / ragging activity inside / outside the college campus during the course of study. Candidates found to be taking part in any such activities mentioned above will be expelled from the course / college, at any point during the course of study and criminal action will be taken against them.
